j. Friends of the Library

Lynne Hagmann the secretary of the Friends of the Westland Library shared her report of activities by the Friends group. Four of the board members attended the FOML (Friends of

Michigan Libraries) workshop at the Novi Library. They discovered that other groups have the same issues that we have here at Westland- not enough space and never enough help. However, we found out that Westland has the best used book prices in the area! They toured the Novi Library and it was amazing to see the new technology. There is an April lobby sale with \$.25 cents or 5 for \$1.00 cookbooks. There is a May book sale that they are calling "The Mother of All Sales" Everything in the room will be \$.25 cents or less. They have registered for The Famers Market Kids Day on July 18, 2019 where the Friends will be giving away free books to kids.

k. 2019/2020 Library Budget

Ishwar and James attended the Budget Study Session at the City of Westland. Council Members asked several engaging questions on the library's future enhancements and planned service upgrades. Ishwar emphasized that we will continually strive to be good stewards of the library's funds and that most of the enhancements will actually directly benefit the community. After all the study sessions are completed, there will be a public hearing on the budget on May 6, 2019 after which City Council will vote formally to adopt it.
