## Salvation Army reaches out with summer bash

The Wayne-Westland Salvation Army, known for its serious mission of helping people in need, will put on its party hat for a summer bash. Capt. Matt O'Neil confirmed Wednesday that a summer block party featuring live Christian bands,

carnival games, inflatable bouncers, fellowship and food will be held 3-7 p.m. Saturday, Aug. 5.

The annual bash, which drew 350 people last year, will be held in the Salvation Army parking lot at 2300 S. Venoy, south of Palmer, in the Norwayne neighborhood where many low-income clients live.

"We want to show that there can be

fun things in Norwayne. It's just another way The Salvation Army can provide for the community," O'Neil said.

The local organization serves Westland, Wayne, Romulus, Inkster and New Boston. The summer block party will be free, and the public is invited, even those not served by the organization.

"We open it up to the whole community," O'Neil said. "It's open to anybody."

The alcohol-free event has proved popular in recent years. It's one of several ways The Salvation Army has attempted to bring some fun to the Norwayne neighborhood and to boost community spirit.

The Salvation Army provides such

services as food for needy residents, after-school tutoring for students having trouble in school, and summer day camp programs for youngsters who otherwise can't afford such outings. The organization also provides church services for the community.

## How does the garden grow?

City, school district join in planting grow zone in city park

Mary Ernat isn't quite the Mary, Mary quite contrary of nursery rhyme lore, but she certainly does have a garden to tend.

A fourth-grade teacher at Schweitzer Elementary, she's spending part of her summer caring for a grow zone along a Rouge River drainage way in Westland's Central City Park that her students and those of Edison Elementary fourth-grade teacher Judith Muller planted as part of the "Rooting for the Rouge" Project.

"It was very thrilling for the students and it was a great help," Muller said. "They knew what to do because it relates to the environment. It all ties in with the fourth-grade science curriculum and the core democratic value of civic duty."

On May 31, 70 students and some of their parents converged on the site which straddles the park's walking path and the drainage way along the western edge of Tot Town to plant 800 wildflower and wild grass plugs.

"When they know the purpose and how it's going to affect them

where they live, they're on task," Ernat said of the planting.

"The kids had an assembly line going," added Lillian Dean, the Rouge Education coordinator for Westland.

According to Dean, "Rooting for the Rouge" came out of discussions between the city's former planning director Tod Kilroy and Wayne-Westland School Superintendent Greg Baracy. The two men were looking at how the city and school district could work together to support education in the community and came up with the Rouge project, which ties in with the fourth-grade science curriculum.

Classes that participate in "Rooting for the Rouge" have planted trees, stenciled storm drains and created buffer growth zones as part of the project. Dean credits Department of Public Service Director Tom Wilson with the creation of the Central City Park grow zone.

"He had a vision and looked for a site and this is the one he preferred," Dean said.

DPS prepared the site, removing

## Livonia district aims at improving communications

In an effort to improve and focus on communication throughout the Livonia Public School District, the Board of Education has established two new ways to engage its constituents.

Community Conversations, informal discussions with trustees hosted a few times each month, will give residents a less structured opportunity to ask questions or discuss con-

cerns about the district. And the board's new Asset Utilization Committee will involve community members in the ongoing discussion of how district property will be used in the future.

On Monday evenings — when there is not a scheduled meeting of the school board — one to three trustees will gather at the board office and give residents a chance to speak candidly regarding any concerns

## Woman's competency delays court hearing

A Westland woman charged with trying to suffocate her blind mother last November still hasn't had a court hearing to determine whether she should stand trial.

Diane Paul, 62, remains in a state forensic center eight months after police said she tried to suffocate her mother with a pillow at the house they shared on Glen Street, near Wayne and Avondale.

A police investigation indicated that the Nov. 25 incident may have happened because Paul mistakenly believed she had somehow messed up her mother's benefits from Medicaid and Social Security.

"She blamed herself for it, and she dreaded caring for her mother without the money," police Sgt. David Heater said. "She wanted her mother to be at peace. She didn't want her to suffer."

Paul, still under psychiatric care, has been ruled incompetent to appear in Westland 18th District Court for a preliminary hearing that will determine whether she should stand trial. The issue of her competency

is expected to be revisited in September, said David Wiacek, court administrator. Her status has been reviewed every three months.

Paul was arraigned in late November for assault with intent to murder. She confessed to police that she had intended to kill her mother, but she gave up after a struggle, Heater has said.

Paul told one police officer that "she couldn't bring herself to finish it," he said.

Paul then left the ranch home and went to her own daughter's house in Westland, and the two of them returned to the Glen residence, Heater has said.

The victim, meanwhile, had reached for a telephone near her bed and began randomly pressing numbers until an operator came on the line and notified police.

Paul had cared for her mother for at least a decade, and police had no indication that the two of them had argued prior to the assault, Heater said.

Authorities described the entire family as traumatized by the incident. Even the victim was in tears after the incident "because her daughter was in jail," Heater has said.

# Firefighters take heat with new training

In a move that could potentially save lives and reduce property damage, Westland firefighters have upgraded their training to battle propane gas fires.

The new skills could prove useful for responding to propane gas fires ranging from backyard grills to huge industrial tanks, Deputy Chief Kevin Riley said.

The Westland Fire Department hosted the training earlier this month on the former Sam's Club site on Central City Parkway. Firefighters from five other communities - Garden City, Canton Township, Wayne, Inkster and South Lyon - also participated.

In all, some 40 firefighters received the training, Assistant Fire Chief Scott Neal said.

Tanks were brought to the site and used for training exercises led by the Michigan Propane Gas Association.

"There was a significant risk of danger (to firefighters) if we didn't do things right," Riley said.

Fortunately, they did. The latest program marked the second time in as many months that firefighters have used the old Sam's Club site to upgrade their skills.

The key to averting a potentially disastrous propane tank explosion is to swiftly respond to a fire and to shut off the valve, regardless of the size of the tank, Neal said.

Firefighters learned a method of spraying propane tanks that pushes the flames away from them so that they can reach the valve and shut it off, fire officials said.

"The fire is external on the tank, so you're trying to redi-

rect the flame and the heat so that you can reach the valve and turn it off," Riley said.

Propane fires can become much more threatening - with the potential for an explosion - unless firefighters reach the scene quickly and address the situation, fire officials said.

Although explosions occur, they are more likely to happen in a rural area where firefighters can't reach the scene as quickly as they can in more populated areas, such as Westland, Neal said.

Firefighters who received the training also can use the skills when battling fires that erupt at natural gas meters, Neal said.

The latest training came as the Westland Fire Department continues to upgrade its firefighting skills, officials have said.

Just last month on the Sam's Club site, firefighters

learned to recognize and prevent a deadly "flashover" - the point at which a fire inside a structure suddenly causes a room to burst into

flames. A special semi-trailer was brought in for that exercise.

# Man reports being beaten with bat

### Condo break-in

A condominium, not lived in for a month as it was being sold, was broken into sometime between 3 p.m. July 5 and 10 a.m. July 11, according to police reports.

The condo is located in Central Parkway Condominiums, off Central City Parkway between Warren and Ford.

The daughter of a woman whose condo was being sold told police that someone broke in and took a toaster oven, clothing, silverware and cleaning supplies. The items were valued at more than \$500, according to police reports.

### Dunkin' bandit

The Dunkin' Donuts at 1625 S. Wayne Road was broken into sometime between 3:30 p.m. Tuesday, July 11, and 8 a.m. Wednesday, July 12, while it was closed for renovations, according to police reports.

An intruder pried open a door and stole plumbing and electrical items that were being used for the renovation, police said. The items were valued at several hundred dollars.

A 24-year-old Westland man told police that he was beaten with a baseball bat and left unconscious behind Jefferson Elementary School about 9 p.m. Thursday, July 13.

The man told police that three carloads of men pulled alongside him while he was walking in front of the school on Dorsey. He estimated that 10 men got out of the cars, surrounded him and began to beat him.

The man told police that one of the assailants accused him of raping of his girlfriend, leading the man to believe he had been mistaken for someone else, according to police reports.


The man told police he was struck in the face with a baseball bat, dragged behind the school and beaten until he was unconscious. He said some neighbors near the school apparently called 911. He was treated at Oakwood Hospital/Annapolis Center in Wayne and released the following day.

According to police reports, the assault resulted in three of the victim's teeth being knocked out. He also received stitches to his lower lip, and he had swelling and bruising to his left eye, forehead, nose, face and back.



 about the district. Board president Lynda Scheel called it a casual "coffee and conversation" time.  
 The concept kicked off July 17. Community members were invited to attend by members of the District Transition Team.  
 Supt. Randy Liepa said the DTT includes "a nice cross-section of people" from all areas of the district. That's why it was chosen as a starting point for this concept.  
 Scheel said not everyone is comfortable speaking to board members during the more formal audience comment time, set aside during televised open meetings.  
 Community Conversations are not open meetings. They will not include a majority number of trustees, but they will create another option for residents of the district.  
 Scheel imagined the conversation would include everything from personal questions from parents about education, to broader topics like the new high

school curriculum standards.  
 The plan is to offer this option from 6:30-8 p.m. a few times a month, as scheduling permits. Upcoming conversations are set for July 24, July 31, and tentatively Aug. 7, Aug. 21 and Sept. 11. To reserve a spot, send e-mail to [transition@livonia.k12.mi.us](mailto:transition@livonia.k12.mi.us).  
 Scheel said she wants the public to know that she and her fellow trustees do listen to concerns and take them into consideration "in every decision we make."  
 Liepa said the open format of his "Breakfast with the Superintendent" chats have proved successful. He hopes the same will be true for the board's Community Conversations.  
 "We want to make sure people feel more comfortable," Scheel said.  
 Other traditional avenues of contacting the school board will remain the same. Board members can be contacted by phone, mail or e-mail, and are at regular and committee meetings to hear audience comments.  
 Community members may also choose to join in discus-

sions that will impact the future of Livonia Public Schools.  
 The board is in the process of establishing an Asset Utilization Committee to look at the assets the district has — land, vacant buildings and more — and determine the best use for them before any decisions are made or direction is taken.  
 Scheel said if the district is considering moving programs or selling land, they'll seek community input. This committee will provide a new way of adding to that charge. She envisions the ad-hoc committee will include parents, residents and professionals — including Realtors — as well as district employees.  
 Scheel said these options are meant to make an impact on long-range planning in the district, and to help board members and the community come together on common ground.  
 "We're looking forward to the beginning of the school year," said Scheel, "to more positive changes and to bringing the community together."

**On-line Freecycle helps find 'homes' for unwanted items**

A woman walks up to a stranger's porch, picks up a bag with her name on it. She takes it back to her car, places it inside and drives away.  
 She is a member of Freecycle and joins thousands of other Wayne County residents, and millions of other people around the world, who are making this same pilgrimage to strangers' homes retrieving items of all shapes, sizes, and values, rescuing them from the landfill.

Freecycle is an International nonprofit organization whose mission is to rescue unwanted, but still good, items that would otherwise go to the landfill and to find them good homes.

Westland resident, Bridget (Rowland) Jarvis, co-moderates the local Freecycle group that serves Westland, Canton, Plymouth, and Livonia.

Jarvis, who was recently named Freecycle's National New Group approval coordinator, monitors the addition of new Freecycle groups across the nation ensuring that only one group serves each geographic area.

"Freecycle is an online gifting community where you can de-clutter your life and turn trash into treasure," Jarvis said. "As I go through my house, anytime I notice something that I don't want or need, I put it aside and post it immediately on Freecycle. When someone e-mails me saying that they can use my unwanted item, it's a good feeling knowing that my stuff is going to good use somewhere."

"It feels good to have the extra space in my home, as well."

Lisa Smith of Westland said she first heard about Freecycle through a friend.

"I was skeptical at first, it sounded too good to be true," she said, "I mean why would someone offer a perfect stranger a stereo when they could sell it? But it was all true and very much real."

How did Freecycle start?  
 In May 2003, founder Deron Beal of Tucson,

Ariz., discovered that his neighbor had hired a dumpster to clean out her garage full of "junk." He e-mailed 40 of his friends to see if they could use any of the items that were about to be sent to the landfill.

Several of his friends showed up and rescued many still useful items from being dumped. Freecycle grew from that single effort and now boasts three million members in 67 countries with more members joining every day.

Polly Kiesznowski has been a member of Freecycle for almost two years.

"Every few weeks or so I post offers; I like to wait until I have a variety of items to offer instead of just one thing at a time," she said. "I have offered everything from children's clothes to hosta plants to an Otis Spunkmeyer Cookie Oven to landscape rocks."

Kiesznowski likes the ease of Freecycle.

"I don't have to load things up and take them somewhere," she said. "People come to my house and pick up from the porch. So far everything that I have offered has been 'wanted' by someone else, even things that I would not think anyone would want."

Jarvis estimates that Freecycle has saved enough items from the landfill to fill three columns of garbage trucks piled to the height of Mt. Everest. She says that almost everyone has e-mail, so there is the potential for a lasting and significant impact on improving the environment as more people learn about Freecycle.

"In the United Kingdom, in just two days, more than 80,000 new members joined after hearing about Freecycle on the BBC," she said.

In March, Jarvis was recognized, along with her co-moderator, Melissa Katchuroff, as one of the top 50 environmental stewards by Waste Management.

"The best thing about Freecycle is the true generosity of the members," Smith said. "In the end we are all members for the same purpose: to keep our unwanted items out of the landfill, and in the process maybe bring a smile to someone's face."

# Readers express their views about LPS board recall election

## Board did its job

When the Demographics Committee investigated and proposed a solution to LPS' financial dilemma, input was solicited from parents and teachers. The community had the opportunity to express concerns and interests. There was no guarantee that anyone's idea would be implemented. Had the board been mandated to implement the most popular solution, an election would have been held. The new system had to be what would be best for LPS, not necessarily what appealed to others. The board was required to implement what they determined to be the best solution — not the most popular. That is the job of the school board.

If the recall happens, the damages to LPS would be inestimable. Moreover, one would have to think twice about running for the vacant positions.

Sure, the school board made a mistake: They asked for public input. I don't think they'll try that again.

Leaders address the underlying problem, not just short-term solutions that put Band-Aids on a deteriorating situation. They lay out the short-term and long-term

solutions and support and answer the concerns of the people who voted them in — not take them to court.

Will a real leader please step up to the plate and help give us some real leadership?

This is ridiculous and a shame. Isn't using fear to manipulate people a tactic of terrorists? It isn't something that should be thrown out as a weapon by our own school board. The opposition isn't much better, but they aren't elected officials either.

## Shows arrogance

I found it interesting that the Livonia Board of Education found it necessary to extend Dr. Liepa's contract another year despite the fact that his contract was not due to expire until June 30, 2008 — two years from now. I assume this had to be voted on prior to Steve King's seating on the Board, and impending recall of five members?

The *Observer* reported that Dr. Liepa received a 2 percent raise making up for no increase last year; his new base salary is now \$124,450. However, I think it is important that the citizens of our community are informed that his W-2 reported wages in 2005 amounted to \$141,535.73 (This true information had to be requested through a FOIA provided by LPS).

Why would the board wait to dispute the number of signatures required for the recall? The fact remains, the Wayne County Clerk released the number of required signatures in February; ample time for the board to refute the numbers. ## Decision on park was correct one

Citizens for Frontier Park should not be surprised nor offended by city officials' decision not to support their plan for a vast recreation complex near Central City Park. Their decision not to back Frontier Park was prudent and correct in light of the state's economic circumstances.

Yes, it would be wonderful to have three multi-purpose turf soccer fields, two sheets of ice, an indoor pool and two additional basketball courts in this city, but now is not the time. Now is the time to focus on hanging on to basic city services.

The plan is ambitious, impressive and massive, and maybe in the good times, it would have been feasible, but these aren't good times and people are struggling. Businesses are closing, people are losing their jobs. While the economy is booming elsewhere in the country, Michigan is teetering on the brink of a depression or may have already entered one, depending on who you talk to.

When the Westland Youth Athletic Association unveiled its plan in February 2005, city leaders told the organization it needed to do more than promote the project. It needed to fill in the information gaps and garner support. The group did fill in the gaps, but it never was quite able to get the support needed to move the project from a conception to reality.

At that time, we asked the city to give the plan strong consideration, saying that it would take recreation to a whole new level. We still believe Frontier Park would do that, but, as we have said, now is not the time.

Citizens for Frontier Park should not give up on their dream of a premier recreation complex. Rather than view the decision as defeat, we hope they will see it as a bump in the road. The decision may mean having to shelve the plan for a few years, but supporters should use the down time to lay the groundwork for reviving the proposal when the good times return.

Frontier Park is an idea that's ahead of its time. Like a fine wine, it needs to set for awhile to become a nice piece of life in Westland.

## Keep our teens from harm's way

There is a series of articles in today's *Observer & Eccentric* examining the myriad of challenges today's young drivers face and the potential dangers posed by teens ill-prepared for the road.

Many of us don't give a second thought to just how dangerous it is to get behind the wheel, despite the hundreds killed and thousands injured every year. Driving is a necessity; for most people, there is no alternative.

Studies show that young drivers in particular are easily distracted while behind the wheel, which increases the likelihood of an accident. When drugs and/or alcohol is added to the mix, the possibility of a tragedy spikes.

Teens see themselves as invincible, that no harm can possibly come to them. Yet nary a week goes by where a family tragedy is not played out in our suburbs.

A promising teen dies of a heroin overdose. Another is critically injured in an automobile accident where the suspected drunken driver runs a red light. Yet another is injured in a swimming accident where alcohol is suspected as a factor.

Keeping our teens out of harm's way takes diligence on the part of parents. And that starts with leading by example.

# Dropouts: A drag on our region, state and nation

I thought of Rev. King's words again recently when I heard (again) that Detroit has the worst dropout rate in the nation. Thinking for a living has replaced lifting for a living in Michigan and across the globe. Gone are the days when one could drop out of school and walk into an auto factory and a middle-class lifestyle. The recent announcement by Google of creating 1,000 new high-paying jobs, requiring a 21st education, in Ann Arbor reinforces this reality.

Where is the public outrage and leadership to address this problem? Every child that drops out of school is another anchor weighing down the renaissance of Detroit, our region, state and nation. It is a terrible waste of human potential. If you do not care for the right moral reasons, you should reflect on Rev. King's words and understand that all of us are tied together. Unless we cast off the dropout anchor, Michigan will never soar. The Editorial Project in Education, supported by the Bill and Melinda Gates Foundation, reported the Detroit Public Schools has the worst graduation rate of the top 50 large urban school districts in America. Detroit Public School officials quickly denounced this study, which further reported that, in 2003, the Detroit schools graduated only a fifth of their students on time. The district quickly provided statistics stating it actually graduated 44.5 percent in 2003 and raised that to 68 percent in 2005.

Boy, am I glad the Detroit school officials clarified these numbers. We should all feel better knowing that more than 50 percent of students did not graduate in 2003 and over 30 percent dropped out in 2005.

Don't shrug your shoulders and think the dropout problem does not impact you simply because you live outside the city limits. Michigan is severely hampered in competing in the 21st century knowledge economy, due to our lack of education for a majority of our residents. Cities, regions, states and countries that educate their citizens are rising, while those which do not are sinking. Areas with high dropout numbers have high welfare rolls, high incarceration rates and high unemployment statistics.

Children who drop out of school do not simply disappear. These children will be coming to your place of business as prospective employees, customers or perhaps to your backdoor with more nefarious ideas in mind.

Where is the public/private investment in

stemming the dropout plague? If these dropout statistics were statistics for cases of bird flu, it would be considered a public health epidemic!

The following are a few recommended action steps to address the dropout problem:

- Challenge the political, civic, business, education, labor and religious communities to develop a proposal to the Gates Foundation seeking resources to get more of our children across the high school finish line. This foundation, the largest focusing on school reform, should be asked to not only fund studies pointing out the problems, but to work with Michigan to address the underlying causes of the dropout epidemic.

- Challenge schools to embrace 21st century e-learning as a tool to stem the dropout tide.

- Invest in high-quality preschool and reading programs to give our youngest students an academic jump-start.

- Create smaller learning environments for high school students that focus on the new four R's — relationships, academic rigor, relevancy and results.

- Create new schools that front-load the excitement of learning, such as a science school at the Detroit Zoo, a school of automotive design and engineering at the GM/Renaissance Center, a health care school at the Detroit Medical Center, a school of the arts at the DIA and a technology school at the Compuware headquarters

- Advocate raising the dropout age from 16 to 18. It is state-sponsored stupidity at best, and institutionalized racism at its very worst, to have a law on the books that makes it "legal" for kids to drop out of school at 16. The dropout rates for poor and minority youths are staggering. If the dropout rates were as high in the suburbs as they are in our cities, perhaps there would be a greater sense of urgency to address the problem.

- Ask — beg — Bob Thompson, the philanthropist who once offered Detroit \$200 million, to build charter high schools, to work with the community to design new educational opportunities for the hundreds if not thousands of Detroit children who leave school without an education or hope for the future.

Our economic and educational opportunities are inextricably linked. We need leadership to take this social eyesore that is more of an anchor to our collective economic upsurge than the restoration of multiple buildings to forge a new coalition to make Detroit the best urban school district in America. It can be done. A true Detroit and Michigan renaissance will not be complete until it is.

### Concerned about recall

For the sake of our children, support Livonia schools. My family lives in the Livonia Public School District and we are concerned about the current recall efforts being carried out by the Citizens for Livonia's Future organization.

I have been an educator for the past 12 years and a school administrator for the past three years. I am currently a middle school assistant principal in Macomb County. My wife has been an elementary school teacher for 13 years and currently teaches in a neighboring school district. We believe that the recall election is and will be damaging to the students of this school district.

The CFLF organization has spent a lot of time distributing literature listing "FACTS" about the Legacy Initiative and our school board. As a parent and as an educator, I am deeply insulted and offended by some of these "facts."

1) A successful recall will not divert educational tax dollars.

FACT: The lawsuit against the district by the CFLF organization has already taken money away from our students. The upcoming recall election will take additional funds away, and the after-effects of a successful recall, such as the potential buyout of our superintendent's contract, could take excessive amounts of money away from our students.

2) A successful recall will afford our students an orderly end to the chaos.

FACT: A recall will create chaos. It will take away local control of our school district for three months. It will replace experienced board members with individuals only interested in one issue and misguided on that particular issue. It will give us school board members prone to "knee-jerk" reactions or too timid to make any tough decisions. This will not benefit the students in our school district, and this is not how I want my children's school district to be operated.

3) Five-six buildings and the added transition that comes with them are damaging to students.

FACT: Five-six buildings work and many districts have had great success utilizing non-traditional grade configurations. I had the pleasure of teaching in the Brandon School District in Oakland County for six years. The Brandon Schools utilize a five-six building and have had much success with it. Brandon High School was recognized by the State of Michigan as a Blue Ribbon Exemplary School. Clearly, the students of the Brandon School District have not been damaged by attending a five-six building. The students attending the Livonia Public Schools will not be damaged by attending five-six buildings either.

The research quoted by the CFLF organization on this matter on their Web page misrepresented the document it was taken from. Their research against five-six buildings was actually taken from an article supporting K-8 buildings. K-8 buildings are not, at present time, a valid option for the Livonia Public Schools.

What research does indicate is that the most important factors contributing to high levels of student achievement are not related to grade span but are directly linked to school leadership, the quality of the teaching staff, school expecta-

tion, staff development and the quality of instructional programs and supplemental services (Georgetown, Texas, ISD, 2004).

The Livonia Board of Education should be applauded for taking a proactive approach to school finance. Sure, some parents may be inconvenienced by the Legacy Initiative. I'm sorry that they have to be inconvenienced, but school districts operate in the best interests of the students, not necessarily their parents. I encourage everyone in the Livonia Public Schools community to approach the Legacy Initiative with an open mind. I think that you just might like the results.

## Graduated licensing lets teens learn skills

Michigan instituted a graduated driver's license program for young drivers in 1997. Teenagers may begin learning how to drive as early as 14 years, 8 months old but must complete two phases of driver education, on road experience and three levels of licensing before they achieve a regular driver's license.

Driver's education courses begin with Segment 1, which consists of 24 hours of classroom instruction and a minimum of six hours behind the wheel training. Segment 2 driver's education consists of a minimum of six hours of classroom instruction designed to provide teens with defensive driving skills.

When a young driver completes Segment 1 of driver's training, the driver can apply for a Level 1 Learner's License. A Certificate of Completion for Segment 1 Training, a birth certificate, a parent/guardian signature and passing a vision screening are required. A Level 1 License is available at a Secretary of State branch office. The recipient may only drive with a licensed parent/guardian or designated adult age 21 or older. The parent/guardian or designated adult must sit in the front seat. If driving with a designated adult, the driver should carry a signed letter of authorization from parent/guardian.

For Segment 2 driver's training, a young driver needs to have completed 30 hours minimum of supervised driving time, including two hours of night driving. A minimum of 90 days since completing Segment 1 is required. Upon completion of Segment 2 training: 50 hours of supervised driving, including 10 hours

of night driving; and 180 days of Level 1 licensing a young driver can apply for road skills testing with an independent testing agency approved by the Secretary of State.

To obtain a Level 2 license, a young driver must be at least 16 years old; meet physical and medical licensing standards; possess of Level 1 license for 180 days; completed Segment 1 and 2 of an approved driver education program; passed a road test; completed a minimum of 50 hours of supervised driving, including 10 hours at night; be violation and suspension free with no at-fault crashes during the 90 days prior to applying for the license; and a have parent/guardian's signature on the application. Level 2 drivers are required to drive with an adult over age 21 between midnight and 5 a.m. unless driving to and from employment. A parent/guardian has the option of requesting in writing that a teen driver remain at Level 2 and not automatically advance to Level 3 at age 17.

To obtain a Level 3 license, a young driver must be 17 years old, have held a Level 2 license for 180 days and have no violations or suspensions and no at-fault crashes for 12 consecutive months prior to applying for the Level 3 license.

Beginning July 1, 2003, drivers under 21 have been issued a vertical license to help retailers and police in identifying underage drivers to prevent the illegal purchase of alcohol and tobacco.

## AAA, Ford sponsor teen driving programs

(This is the first of a two-part look at teenage drivers.)

Kelsey McInnes, 16, Jenny Wells, 15, and Marie Czarnomski, 15, all of Redford know the dangers of driving, but they also know the rewards.

"To have freedom," Kelsey said.

"I just like driving," Jenny said.

The three were part of a Segment 1 drivers training class at the A&A Driving School on Seven Mile in Livonia.

They are at the beginning of a long process of instruction and behind the wheel experience before they obtain their final license under Michigan's graduated license program.

"I think it's a good idea to be sure you can drive well before you get your license and go out on the road," Kelsey said.


"It gives you more opportunity to practice," Jenny said.

And practice may be the best way to prevent car crashes involving teen drivers.

Vehicle crashes are the No. 1 killer of teenagers in Michigan and the United States.

According to the National Highway Traffic Safety Administration, 173 teenagers 16-20 died in traffic fatalities in 2004. Nationally nearly 6,000 teen drivers were killed in 2004.

"The No. 1 reason for teen accidents is a lack of experience," said Jim Graham of the Ford Fund. "When they get a driver's license, they don't have those driving skills, they lack experience. Drinking, seat belt use are important, but experience is the key problem."



In the Hazard Recognition phase, teens have to react quickly and go in the proper direction when one of three red lights suddenly turns green.

### DRIVER PROGRAMS

Ford Motor Co. and AAA Michigan are promoting programs to improve the skills of young drivers. The Ford Fund has created the Driving Skills for Life program with an interactive Web site and a four-day drivers summer camp. AAA Michigan has released two DVDs for teen drivers, sponsors a parent-teen driving contract and is lobbying for changes in Michigan's graduated license program.

"We look at four areas: hazard recognition, kids aren't good at that; vehicle handling; speed management; and space management, how to tell distance and stopping," Graham said.

An interactive Web site at [www.drivingskillsforlife.com](http://www.drivingskillsforlife.com) navigates young drivers through a program on each of these items.

"We have a lot of modules," Graham said. "It takes you through the four areas and you answer questions. There are a couple of simulation games that teach in a more fun way... There are things for teens, parents and educators."

Beginning in spring, AAA

Michigan has been giving free copies of the DVD *Young Drivers: The High Risk Years*, which explains why crash rates are so much higher for young drivers and offers guidelines for parents on helping to lower the risk.

"It's available to whoever stops by a triple-A office, members and non-members," said Jim Peet, manager of community safety services for AAA Michigan.

In addition, the company has just released an interactive DVD, *Drivers Zed*. The DVD, available for \$10 to AAA members and \$15 for non-members, takes teens through 80 highway, city, country and work zone scenarios.

"It's a good program that parents can watch with teens," Peet said. "In addition, we have a lot of education programs, going out to schools."

### PARENTAL INVOLVEMENT

Both AAA and Ford emphasize parental involvement in driver education. AAA is promoting a Parent-to-Parent contract and a Parent-Teen Safe Driving Contract. The Parent-

to-Parent contract encourages parents to "adopt a shared view and approach to their teens' driving." The topics covered in the contract include nighttime restrictions, passenger restrictions, seat belt use and good driving behavior. The Parent-Teen Safe Driving Contract spells out consequences for violating a number of rules of the road and sets privileges, which can be adjusted as the driver gains experience.

In addition, AAA is lobbying to amend Michigan's graduated license to restrict the number of other teens allowed in a car with a teenage driver.

"Adding other teens in a car just increases the chances of being in a serious crash," Peet said. "Even though it isn't the law, we encourage parents to do that. It's something they should consider. We are pushing to limit the number. Some states have no other teens in a car other than a sibling or parent."

He said some parents have resisted this change because so many young people are involved in car pools. He said the Secretary of State's office has also opposed changing the graduated license program.

The Ford Fund is sponsoring a four-day summer camp, Aug. 1-4 at Ford's Michigan Proving Grounds in Romeo. Graham said the program is open to high school students in metro Detroit.

"We'll take 250 teenagers a day, similar to our ride and drives around the country, taking them through the four areas of concern, hands on with professional drivers," he said. "It's a great, fun day for teenagers. It's free, just sign up."


